Funding Needs

The cost of the Kansas Agriculture and Rural Leadership Program is approximately \$500,000 per class, or nearly \$17,000 per class member. The costs are based on services needed to carry out program activities. Members provide \$3,000 each -- \$90,000 total -- toward program costs.
